#### Teaching and Curricular Achievements

#### **IESE Business School:**

o Entrepreneurship Course. Taught in 5 different programs, including the MBA, EMBA, and Executive Programs such as the Program for Management Development (PMD), and the Advanced Management Program (AMP). This course develops the main concepts of entrepreneurial management. It pursues two main objectives. First, it aims at enabling

- participants to turn an idea into a revenue-generating business. Second, the course makes the process of entrepreneurship clear and understandable.
- o Sustainable Entrepreneurship in MBA and GEMBA. This course examines key concepts of entrepreneurship, using the Sustainable Development Goals (SDGs) as guiding principles. It explores how new ventures, non-profits, and other companies address and advance the SDGs through their innovation.
- O Contemporary Topics in Entrepreneurship, Social Change, and Governance in Master of Research in Management program. This course seeks to provide a deep understanding of the linkages between entrepreneurship, social change, and governance. It is built from the premise that governance is a central and foundational topic in assessing how entrepreneurial action can contribute to the public good. It also examines important interdisciplinary research at the intersection of entrepreneurship and social change, including social and environmental entrepreneurship, gender issues, impact investing, institutional change, industry development and evolution, and field experiments, amongst others.
- Corporate Entrepreneurship, in EMBA program. This course provides an understanding of how corporations apply and structure innovation and the challenges, and possible mitigation, of these efforts. Students become familiar with different ways of organizing for open innovation and more specifically, how corporations work with startups. Students apply the entrepreneurial mindset in a corporate context and understand the alternatives to scan outside the firm for innovation. They also explore the entrepreneurial ecosystem that supports and enhances this activity.

This course takes a unique approach to business strategy by integrating the principal aspects of strategic management and entrepreneurship while students apply these concepts in a Capstone project with local firms and organizations.
